I posted a rather tame response on your FB "wall" which you have most probably read.

It reads:

Your email to me, "not crazy about FB", why would you say that when you are so active?

An Israeli girl, who happens to be most beautiful, says that people use FB to spy on the social activities of their friends.

Do you think that is more the case than wanting to find someone rich to marry?

BTW, what did you think of my last communique to my one webmaster Adam L. Tucker whose mother back in 1991/1992 dated a Jewish CIA operative who is pissed off with me because I placed up on my website 2facetruth.com an account of the meeting that took place between Adam and him back on December 23rd, 2008?

Don't you think that is more interesting stuff than all the chit-chat and not explaining why you blew me off this weekend, which is not to suggest you have turned, gay?

Ps - I know everything, with everyone, comes down to money. There are no saints on this planet. Brothers selling out brothers and sisters selling out sisters and brothers didn't start just yesterday, and yet look how many of you put on such a charade that you care about your family.
